DEMONSTRATE AN UNDERSTANDING OF THE REQUIREMENTS OF LEGISLATION WITH REGARDS TO:

- the purpose of health and safety legislation relevant to the workplace environment
- the rights and responsibilities of employees and employers
- safety signs and symbols, their identification and purpose
- the importance of personal protective clothing and safety gear
- colour codes on pipelines, their identification and purpose

DEMONSTRATE AN UNDERSTANDING OF SAFE WORKING PRACTICES

- Identify hazards in their environment and describe the standard operating procedures and regulations, including reporting, employed to maintain personal, workplace and equipment safety.
- Participate in the Company's safety program, from identifying hazards, assessing risk, controlling hazards, to monitoring and evaluating effectiveness.
- Identify and describe the good housekeeping, hygiene and personal safety practices and precautions required when handling chemicals, gas, electricity and machinery.
- Select the correct protective clothing and safety gear to wear when working with specific hazards and explain the purpose of each item.
- Demonstrate the correct lifting and handling techniques of heavy objects.
- Explain the importance of keeping the body alert through avoiding alcohol and drugs, and having sufficient good sleep and nutrition in order to perform work safely.

DEAL WITH SAFETY EMERGENCY SITUATIONS

- Identify possible safety emergency situations.
- Explain the procedure for reporting emergencies.
- Explain the purpose and responsibilities of a safety and emergency representative.
- Identify the appropriate extinguishers to use in putting out fires and explain the emergency procedure in the event of a fire.
- Explain the emergency procedure in the event of a chemical spill, gas leak, exposure to live electricity and an accident.
